Rates effective June 1, 2026 through December 27, 2026

Effective June 1, 2026, there will be an increase to the wage rate for the CECWs and a new HRA contribution. See below for new rates:

- (a) Effective 6/1/2026, there is an HRA contribution in addition to the existing health plan contribution. See Page 3 for details.
 Los Angeles local terms: Workers with the CW-A classification shall receive FMCP Plan 14 Single coverage after attaining 1,000 hours of work in the classification.
- (b) NEBF contribution is an amount equal to 3% of the gross wage.
- (c) NECA Service Charge is an amount equal to 1% of gross wage and is paid by NECA members only. AMF is an amount equal to 0.5% of gross wage and is paid by non-NECA members only.
- (d) Working dues rate at time of publication; For questions on working dues please contact IBEW Local 11 at 626-243-9700.
- (e) The minimum hourly rates of wages and benefits for Inside Journeymen, Foremen, General Foremen, and Apprentices shall be per the work site Local Inside CBA.
- (f) Other than an Inside Wireman, only a Construction Electrician Level 2 with a valid City, County and/or State License/Certification may be designated as a jobsite lead/foreman, whose wage scale will be as determined above, plus 13%.

Changes to the CECW MOU as of May 26, 2025

1. **Term:** May 26, 2025 through May 31, 2030 (5 years)
2. **Rename** NEIF to NECA Service Charge.
3. **AMF** rate is changed to an amount equal to 0.5% of gross wage and is paid by non-NECA members only.
4. **Add the following language to MOU:** Except in the event of unforeseen circumstances, provide a minimum 2 weeks notification to the employer’s payroll department prior to changing classification to JW.
5. **Change foreman rate** to 13% above CE-2.
6. **Add HRA** to health plan effective 6/1/2026. See chart below for HRA rates.
7. **Wage changes:** See chart below.
